During the **"Take Back the Night"** event, we registered 13 students to vote, updated the voter records of three other students and passed out brochures on the League. Many thanks to Susan Saunders, Ruth Stemler, student volunteer Maren Rosenbach and Giorgio Ausenda for helping at that event.

Taking Action: Campaign Finance Reform Team

The goal of the Campaign Finance Reform (CFR) team during 2015 was to educate people about the vast amount of money in our American elections that is provided by very few wealthy individuals and corporations. The presentation was given 22 times, and the Denver, Pueblo and Larimer Leagues have used the presentation. A wealth of information about money in elections has been placed on our <u>LWVBC website</u>, including the presentation, for anyone to use. In addition, each month we send out a '<u>Follow the Money Blast</u>' with new information.

The committee spent considerable time and effort reviewing the material provided by the Money in Politics (MIP) LWVUS committee and in preparing for our League's consensus meetings on MIP.

Since the problem of money in elections is now widely known in the US our team's focus has moved to publicly financed campaigns. Our efforts will be focused on encouraging other cities in Boulder County to implement a public campaign finance system which could be similar to that of Boulder City. In addition, we will be looking at the details of existing publicly financed campaign systems in cities and states around the country. Our team very much welcomes new members. 
On 7 April, the Boulder County Bar Association (BCBA) held its 29th Annual Pro Bono Luncheon at the Marriott Hotel. Four LWVBC members attended the awards luncheon, sponsored by Boulder County Legal Services (BCLS), and were among the 200 or so attendees—mostly lawyers, judges, law students, and professional staff—who gave Louisa a well-deserved standing ovation. BCLS lawyers deal with civil matters, including family law, housing, and benefits.

Louisa Young was president of LWVBC from 2012 – 2014. She continues to serve on our board and contributes her professional expertise as a member of our Social Policy and Agriculture teams, as well as numerous special projects. Louisa serves as co-chair of the Fund Development Team, and she will be working on a task force to assess the feasibility of a paid administrator for LWVBC. She coordinated the application for a large grant to help fund the Internship program. In 2007, Louisa did the legal work - pro bono, of course - for the merger of the Longmont and Boulder Valley LWVs to form the LWVBC.

Membership Activities

Trying new things and /or responding to special circumstances have the drawback that there is no instruction book to guide one's actions. But for those who like variety in our activities, these unexpected opportunities can be very enjoyable. I was a resource from the community and a judge to the high school students who competed in the Doing Democracy Day (DDD) VII on 29 March in Longmont. In this article I will share my reflections on that experience.

Doing Democracy Day

This is the second year that our league has sent volunteers to DDD, and this year our members staffed a voter registration table and we put in some money to be listed as a Sponsor! The St Vrain Schools is the major sponsor in that they provide substitutes so that teachers from all the high schools can accompany 5 students each for the event which takes place on a Tuesday. After students check in, they are fed and given tips on how to evaluate the merits of different policy choices and on how to interact with and interview the community leaders.

A highlight for me was the keynote address by Public Safety Chief Mike Butler. "Police departments have way too much power," he said. 80% of incoming calls do not involve any crime. He concluded that citizens need to step up and take on the roles of caring, acting and finding solutions. "True democracies are made by great citizens."

The DDD committee had a new question this year which corresponded to a bill being considered at the state legislature. In order to graduate from high school, must all students pass the same multiple-choice test which is a requirement in the process of naturalization? The winners at the end of the day were one of two teams that made their presentation on this topic. In the preliminary round, because of glitches with the venue's WiFi, the four teams that I judged faced the challenge of having to do their entire presentation without the use of the slides and visual aids they'd prepared. When not talking to students and other leaguers or eating, I did some networking with other adults and came away with some new names for our league's master contact list.

Consensus Updates

Last fall, our membership weighed in on three consensus questions: LWVUS: Amending the Constitution; LWVCO: Behavioral Health; and LWVUS: Money in Politics. The results of those consensus activities have now been reported:

Constitutional Convention: LWVUS Position

On 3 February 2016, the League of Women Voters US announced a <u>new position</u> that calls for safeguards to govern the constitutional convention process of proposing amendments to the US Constitution. Specifically, the League supports these safeguards:

- 1) The Convention must be transparent and not conducted in secret;
- 2) Representation at the Convention must be based on population rather than one state, one vote; and delegates should be elected rather than appointed;
- 3) Voting at the Convention must be by delegate, not by state;
- 4) The Convention must be limited to a specific topic;
- 5) Only state resolutions on a single topic count when determining if a Convention should be called; and
- 6) The validity of state calls for an Article V Constitutional Convention should be determined by the most recent action of the state.

Behavioral Health: LWVCO Position

Our recent Behavioral Health Study provided the position to bring to the national Convention. The LWVCO has learned that the LWVUS Board of Directors has recommended Colorado's Behavioral Health Concurrence for the LWVUS Convention agenda.

A full statement of the LWVCO position and the history of our involvement in health issues are available on the <u>website</u>. In brief, the <u>League of Women Voters of Colorado</u> has adopted the following position:

Behavioral Health: (Adopted 2015)

Support for:

- Behavioral Health as the nationally accepted term that includes both mental illness and substance use disorder.
- Access for all people to affordable, quality in- and out-patient behavioral health care, including needed medications and supportive services.
- Behavioral Health care that is integrated with, and achieves parity with, physical health care.
- Early and affordable behavioral health diagnosis and treatment for children and youth from early childhood through adolescence.
- Early and appropriate diagnosis and treatment for children and adolescents that is family-focused and community-based.
- Access to safe and stable housing for people with behavioral health challenges, including those who are chronically homeless.
- Effective re-entry planning and follow-up for people released from both behavioral health hospitalization and the criminal justice system.

Behavioral Health: LWVCO Position (continued)

- Problem solving or specialty courts, including mental health and drug courts, in all judicial districts to provide needed treatment and avoid inappropriate entry into the criminal justice system.
- Health education from early childhood throughout life that integrates all aspects of social, emotional and physical health and wellness.
- Efforts to decrease the stigmatization of, and normalize, behavioral health problems and care.

Money in Politics: LWVUS Position

On April 14 the national League of Women Voters announced a new Money in Politics position and its support for legislation to reform the Federal Election Commission (FEC). The <u>announcement</u> and the <u>position</u> are posted on the LWVUS website.

The positions were based on consensus reached by 336 local and state Leagues and Inter-League Organizations who participated in the Money in Politics study. In addition to the traditional reason for campaign finance regulation – preventing corruption and undue influence in government – the League now supports several other goals, including: enhancing political equality for all citizens, protecting representative democracy from being distorted by big spending in election campaigns, providing voters sufficient information about candidates and campaign issues to make informed choices, ensuring transparency and the public's right to know who is using money to influence elections, and enabling candidates to compete equitably for public office.

TAKE ACTION

On 27 April 2016, LWVUS President, Elisabeth MacNamara issued a <u>call for action</u> in support of efforts to reform the Federal Election Commission (FEC).

The League has endorsed legislation by Senator Tom Udall (D-NM) and Representative David Price (D-NC) that would create a new independent agency to replace the FEC. The new Federal Election Administration (FEA) would be comprised of five commissioners, appointed by the President and confirmed by the Senate, where only two members can be from the same political party. The fifth commissioner would be appointed on a nonpartisan basis from a list of candidates selected by a blue-ribbon panel of retired federal judges, former law enforcement officials or individuals with election law experience. With this five-member structure, the new legislation would end gridlock at the commission and put the public's interests over partisan interests.




