

Voter Service: The Dog Days of Summer

The dog days of summer are upon us but that hasn't slowed down the Voter Service Team.



The voter registration drive (VRD) section set up shop at the Colorado Latino Festival in Boulder Central Park on Sunday, August 4th. A poster was displayed that attendees could sign, pledging to be counted in the 2020 census. As you can see from the attached photo, the poster drew many signatories, including the signature of Lt. Governor Dianne Primavera! Twenty-six festival attendees also filled out cards pledging to educate their community about the importance of the 2020 census. Although attendance at the festival was light, the table had a steady stream of visitors, including eleven voter

registrations.

On August 8th, the VRD section was at the Erie Farmer's Market where a poster on the National Popular Vote Compact drew many questions and discussions with passersby. Five voters were registered, including one woman in her mid-thirties who registered to vote for the first time.

On August 17th, the League was invited to conduct an informational table at the Longmont Public Library Volunteer Fair. Many folks stopped by the table to inquire about the LWV and 14 signed-up to receive emails on upcoming LWVBC events. Several people filled forms expressing a desire to be contacted concerning future volunteer opportunities. During the event, a Longmont educator also inquired about the feasibility of the League meeting with the Longmont Youth Advisory Council. As a result, a meeting was scheduled for August 27th to learn more about what the young people do as Council members and how they might join forces with the LWVBC.

Assist by volunteering for the forums and ballot issue presentations - it is assistance if you bring another person to any or all of these activities

Remember the LWV's responsibility is to educate voters so they may make informed decisions.

At the same time members have been preparing for the elections, the leadership, both board members and Issue Team leaders, have initiated the strategic planning process for our next 3 years. (Learn more at the Fall Kickoff.) The past 4 and a half years we've worked at making our league visible and recognized as a resource for the county. This resulted in a 32% increase in membership! At the same time we introduced a more interactive webpage so it's easier to join the League and much easier to find information about all our meetings - the what, where and when details are all easy to find on the home page in the blue Upcoming Events box or under the Events tab at the top of the page. Please make an effort to stay involved by attending activities planned by your fellow members.

September is a month of getting ready for the elections. October will bring candidate forums and ballot issue presentations. We will be doing numerous Voter Registration Drives around the county in both months (see our website). Also in September, we have many exciting events:

- Sunday, September 22, 3:00-5:00: Film screening of "Councilwoman", followed by discussion. At the Longmont Museum. Cost: \$5.

- Saturday, September 28, 10:00-11:30: Fall Kickoff meeting, at Lafayette Senior Center. Cost: Free.
- Sunday, September 29: YWCA's Dash and Bash, at the Boulder Reservoir. Join and/or support LWVBC's team! (Information elsewhere in the Voter.)

Strategic Planning update

We have finished the assessment and retreat phases of our strategic planning efforts. Many thanks to all who participated—we value your input! We had 3 focus groups, with 28 members participating. We sent out a survey to our members in early August, and 45 members responded—excellent!

Then, on August 10, we held a strategic planning retreat, with board members and issue team leaders. 14 participated in the retreat. We reviewed data collected over the last 4 years (since our last strategic plan), and we found some impressive trends. We also reviewed the results of the assessments, and we worked to identify our highest priorities for the next 3 years.


Rossana Longo-Better at KGNU Community Radio

Free Documentary Film Showing: **United States of ALEC**

Hosted by LWVBC Money in Politics Team



Why would Congress, or our State legislature, pass bills that maximize corporate profit at the expense of citizens, and of voting rights? Come watch the Bill Moyers and Company film called *United States of ALEC*, Saturday, September 14th, 2019, from 2:00 to 4:00 PM at the Lafayette Public Library, 775 Baseline, 303-665-5200. We will hold a discussion afterwards. As the [Bill Moyers and Company website](#) states,

Moyers & Company presents 'United States of ALEC,' (sic) a report on the most influential corporate-funded political force most of America has *never* heard of – **ALEC, the American Legislative Exchange Council**. A national consortium of state politicians and powerful corporations, ALEC presents itself as a 'nonpartisan public-private partnership.' But behind that mantra lies a vast network of corporate lobbying and political action aimed to increase corporate profits at public expense without public knowledge.

Using interviews, documents, and field reporting, the episode explores ALEC's self-serving machine at work, acting in a way one Wisconsin politician describes as 'a corporate dating service for lonely legislators and corporate special interests.'

In state houses around the country, hundreds of pieces of boilerplate ALEC legislation are proposed or enacted that would, among other things, dilute collective bargaining rights, make it harder for some Americans to vote, and limit corporate liability for harm caused to consumers – each accomplished without the public ever knowing who's behind it.
