# Registering Voters in 2020 – We Need Your Help


Colorado will conduct its 2020 presidential primary on Super Tuesday, March 3, 2020. Consequently, although the ink has barely dried on the 2019 election, voter registration drive (VRD) planning must occur much earlier in 2020 than has been the case in prior presidential election years. Additionally, as you may know, the Colorado Secretary of State requires annual training for all persons participating in VRDs even if the person took the mandatory training in the prior election year.

Do you want to help the LWVBC register voters in 2020? If so, Voter Service will be conducting a mandatory 2020 VRD training on Saturday, January 25, 2020 from 9:30 a.m. to 11:00 a.m. You must register in advance to participate in the training. The doors will open at 9:00 a.m. and training will start promptly at 9:30 a.m. Please go to the lwvbc.org website and, in the "Upcoming Events" calendar on the right, scroll down to January 25, 2020 to register for the VRD training I do ask that anyone taking the VRD training make a commitment to volunteer at a minimum of three VRD events in 2020. (Typically, volunteering at each VRD event is a 2 or 2 ½ hour time commitment). Rest assured that there will be plenty of VRD volunteer opportunities between February and October 2020!

# **Good News on Wages**

The LWVBC with its partners in the Longmont Living Wage Coalition achieved an important victory from the Longmont City Council. City Council members on September 17 voted unanimously to raise the city's hourly wage for full-time employees and full-time contract employees to \$17.42.

The Colorado Legislature repealed the prohibition on increasing local minimum wage - a measure the League has long supported.

# Support LWVBC with Your IRA Distribution

The end of this year is approaching. League members who have one or more Individual Retirement Accounts (IRAs) should think about directing your retirement account manager to send all or a portion of your Minimum Required Distribution directly to the League of Women Voters of Boulder County. This is a wonderful way to support the LWVBC – and if the distribution is sent *directly to the League* it will not be taxable. Call your financial manager quickly, before the distribution is sent to you, to qualify for the charitable tax deduction. And then notify the League office of your gift, since distributions are sometimes sent without any notice of who the donor is.



LWVCO (and the <u>LWVBC Voting Methods Team</u>) notes that guaranteeing a majority is often impossible and problematic for a variety of reasons.

#### Consensus Process for Non-citizen Rights - and the Consensus Process in General

#### No Consensus on Non-citizen Rights

After receiving a report of the consensus results supporting a variety of non-citizen rights as it relates to voting, the board has voted to not adopt the consensus. The LWVBC will not have a position at this point.

<u>Editor's note</u>: Correction - The Board voted against a suggested simplification of the draft position statement. It did not vote on adoption of consensus.

#### Note on Consensus Process for Non-citizen Rights

We are nearing conclusion of the LWVBC's consensus process for non-citizen rights. Following lengthy discussion at the November Board meeting, the Board members deferred a final decision on the draft position statement. Instead they asked the Social Policy Team for clarity on a residency requirement, if any, for non-citizens. Also, the Team was asked for input regarding the post-election experience in communities with non-citizen voting rights, including local Leagues' experience and/or participation in the process of bringing those rights to their communities.

As a member of the League's Social Policy Team and because I wanted to understand our members' thoughts on rights of non-citizens, I attended all three consensus meetings on that topic. I participated in the one held at the Louisville library, I observed and contributed a few bits of information at the meeting held at Frasier, and I facilitated the discussion at the final meeting at Front Range Community College in Longmont. I have stayed an active leaguer for years and one of the reasons this organization appeals to me is that program decisions are made from the bottom up, at the grass roots level, by members. I was gratified to know that a number of individuals, primarily younger adults, had joined the league specifically because they wanted a say in the local league's process of working towards adoption of a position on rights of non-citizens. I was discouraged that so few members came to the meetings, but I assumed that those who were absent would gracefully accept that the opinions expressed by those who took part in the consensus were representative of the views of the overall membership.

The team members met and compared our notes from the three meetings and then carefully drafted a statement to fairly reflect the degree to which meeting participants had and had not achieved consensus on the rights of non-citizens. We were shocked and even outraged when the local league board rejected the draft statement without even taking a vote, for lack of a second to the motion.

Elsewhere in this newsletter the co-presidents will no doubt explain the board's action, but here I want to tell why I found it so disappointing. What follows are my opinions; I am not attempting to represent anyone else on the social policy team. To me, the board's actions shows lack of respect for our members and for the grass roots concept. Every year members are asked what issues they wish to study and take action on, also to reaffirm or put aside each of the local program positions previously adopted. Every two years we are asked do the same to determine the direction of the league at the state and national levels. But in recent years the powers that be at the state and national league seem little interested in members views. They warn us not to push for new studies, they tell us of the importance of diversity, equity, inclusion. They recommend to us certain priorities for action at all levels, regardless of what might be happening in our local community. If it worries you as it does me that the local league now follows the top-down approach modeled by the state and national levels, please consider how you might act to steer the league back in line with its heritage of being a bottom-up association.

#### Contentious Consensus?

Reaching consensus is a process encouraging civil discourse amongst members regarding topics of importance to the League and potentially to the community. The LWVBC has had a surge in numbers of new members for whom the process is always a little mysterious. The Social Policy Team (SPT) included in the June 2019 VOTER, a brief statement of the process with its materials leading up to the fall consensus meetings. The process, particularly this year, has brought up some questions about the practice and we'd like to collect some feedback. We'll be sending you a survey in January and hope you will feel engaged enough to respond, even if it's to ask your own questions. We'll probably start with something like the following:

- •Do you participate in the consensus process, in those years when it takes place?
- •If you don't participate in the consensus process, why not?

The process determines the "sense" of the group, not a majority or unanimity:

- •Do you think the process works well?
- •If you participated this year or past years, do you feel your voice was heard?
- •Do you think a certain percentage of the membership needs to participate to reach consensus?
- •Can members bring up questions to be resolved in addition to pre-published questions?
- •Do you have suggestions or questions regarding the process?

It's worthwhile for organizations to review their practices whether or not it results in changes. Please be thinking about consensus and your part in it.

- 3. Scroll to the bottom of the <u>Additional Member Data</u> screen to see where to enter your race/ethnicity or to check that your entry is correct. Enter your birth year on this page as well. It's also a good idea to review your other data while you are on this page. Update your *Skills*: Notice that we have added *fluent in Spanish*. We would greatly appreciate knowing who might help us with attending meetings with Latinx groups! You can also type in what *Other* skills you would like to list. Update your *Needs*: Notice that we have added *childcare*, *rides* and *handicap assistance* as options.
- 4. Return to your <u>Profile</u> page and under <u>Website</u> update your <u>Interests</u>: <u>Climate Change/Environment, TABOR,</u> and <u>Voter Service 2020 Elections</u> are new options to choose.
- 5. Return to your Profile page and under Personal Info click Contact Info to check or update your gender.
