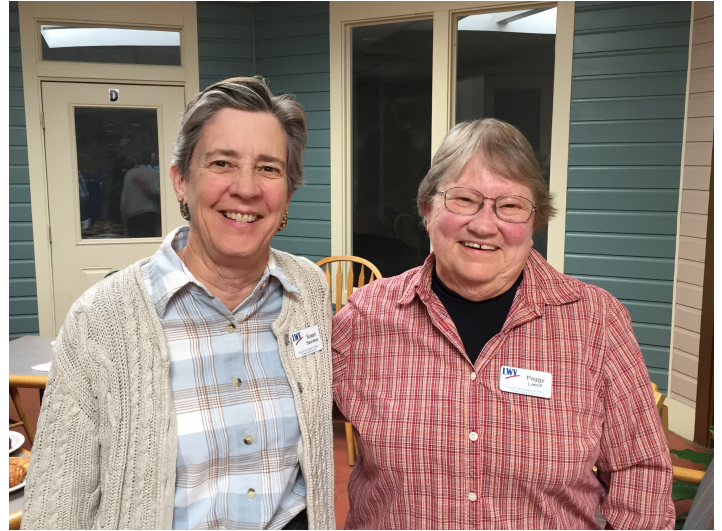

Presidents' Letter

The time has come for the Nominating Committee to do its work. Board members are working on a new model for our board structure, with the intent to increase the diversity of its members. We have come to realize that a Board of Directors might best spend its time on defining the big picture of where the LWVBC can be most visible and effective in empowering voters and defending democracy. Update on Climate Change Lawsuit

Last year, the LWVUS filed a 'friend of the court' brief on behalf of the plaintiffs in *Juliana v. United States*, brought in 2015 by [Our Children's Trust](#). The 21 youth plaintiffs (including Boulder man Xiuhtezcatl Martinez) allege that the government is violating their constitutional rights by promoting the development and use of fossil fuels, despite knowing for decades that fossil fuels are destroying the climate system. On January 17, 2020, the Ninth Circuit Court found primarily for the plaintiffs but held that the U.S. government cannot stop climate change. Counsel for the plaintiffs says, "The *Juliana* case is far from over." Read more [here](#).

Generous Legacy Gift From Patricia Johnson

The LWVBC learned recently that Patricia Johnson, who died in October 2019, aged 93, left a wonderful legacy gift to the Boulder County League. We have received a bequest of just over \$17,000!

Pat, who served as president of LWVBC and of the Colorado League, had a remarkable life. Following her graduation from Oberlin she found work at the CIA, starting as a secretary since women were not considered for positions as agents at the time. However, her skills were recognized and she served in Washington DC, Vienna, Mexico and Saigon before she and her husband, also with the CIA, retired to Boulder in 1977. Pat was attractive, stylish and well-spoken. She became a powerful force in her adopted community and supported the Colorado Music Festival and the LWVBC, where her last position was as Fund Development Director; she was an expert on campaign finance and an impressive speaker.

Friends who spoke at her memorial on Jan. 24 described her devotion to music, to the League and to her friends. When Pat made her estate plan, she had no idea what future circumstances might be. We have received her bequest just as LWVBC is beginning an incredibly challenging year, and Pat's gift will help us go forward. She will be missed by those who knew her, and we are immensely grateful for her generosity.

Issues For Action! 2020 (Formerly Called Program Planning)

It is time to discuss Program Planning. This year we are following LWVCO's lead by naming Program Planning, "Issues for Action." We recognize this name change may require some adjusting, and we appreciate your help in making the transition seamless.

This is the year we will review Issues for Action on the local league level for the upcoming 2020-2021 year and Issues for Action on the national league level for the years 2020-2022.

The first Issues for Action meeting will be on February 6 from 1 to 2:30 at the Meadows Public Library in Boulder.

The second meeting will be the evening of February 11 from 6-7:30 at the Lafayette Public Library. Please make every effort to attend one of the meetings as this is the only full membership meeting where members can:

- ~ Identify Issues for Action to pursue on the local level and
- ~ Recommend additions to, revisions to, or deletions of existing league positions on the local and national levels.

The 90 minute meeting will be divided into four parts:

1) On the national level, we will discuss and vote to support or oppose two issues: a proposed concurrence proposed by state leagues on the topic of Voting Methods (CO and other states sponsored a new position); and a request by the Illinois LWV to make abolishing the Electoral College an action focus on the national level.

2) On the state level, we will discuss whether we want the LWVCO board to support, stay neutral or oppose a 2020 state ballot initiative to change the state constitution to say "only" citizens can vote in all elections instead of the current "every" citizen can vote in all elections.

3) We will review the existing public policy positions held by national LWV and our local LWVBC. Members can propose to retain, revise, or delete policy positions.

4) The team leaders of LWVBC Issue Teams and Voter Services will present their Issues for Action for the 2020-2021 year. The six Issue Teams are: the 2020 Census; National Popular Vote; Voting Methods; Money in Politics; and Social Policy and Schools. Please consider offering to volunteer with any of these Issue teams as well as with operations. We have less than a half time staff person, and rely on our members!

Possible Win-Win for a Proposed National Concurrence

Our LWVBC Voting Methods Team and LWVCO may have reached a win-win solution with the proponents of the proposed concurrence on Voter Representation/Electoral Systems. We suggested replacing the “majority bullet point” with the following language which basically comes from our state position:

Strive for an election outcome that more accurately represents voter preferences.

The proponents of the original language responded, “We will propose your suggested language and share your letter with the state leaders that worked on this concurrence with us. And of course we will share your language with the LWVUS Board as well.”

In elections with more than 2 candidates, a majority is often impossible to achieve. The LWVUS *Impact on Issues* calls for a “broad and general” position. Mathematically accuracy is also an important goal.

LWVUS is piloting a new process with this proposed concurrence and has asked for feedback from Local Leagues. A very recent twist in the process is the sudden addition of the following line at the bottom of the proposal:

The position is not meant to overtake state positions already decided on alternative elections systems, but as an add-on for states that do not yet have a position.



We are not sure how this change came about nor how to interpret a national position that can be overruled by a state position since the League should be speaking with one voice. The conversation continues...

In an effort to register as many voters as possible before the Presidential Primary, Voter Service is making a big push to schedule multiple VRDs. Consequently, between January 26th and February 9th, there are nine VRDs scheduled across Boulder County. Although all of the volunteer slots for these events have been filled, trained volunteers should frequently check for new VRD volunteer opportunities at the lwvbc.org home page under "Upcoming Events." We will be having many more VRDs over the coming months.

Throughout the 2020 election year, Voter Service will be focusing on registering and educating youth and people of color across the county. To that end, we have partnered with The Latino Task Force of Boulder County and the American Association of University Women to assist us in conducting VRDs within the targeted populations. Additionally, I am pleased to announce that Martha Dever has agreed to fill the newly created position of Voter Registration Youth Coordinator. Martha has extensive experience as a public-school teacher, a university professor and a university administrator. She will be reaching out to the high schools in Boulder County offering the LWVBC's expertise to assist in registering youth 16 years of age and older consistent with Colorado election laws passed in 2019.

VRD Coordinator position: Voter Service continues to seek a person to take over as VRD Coordinator. (I continue to do the VRD Coordinator job as well as the Voter Service Director job until this position is filled). This person will be responsible for scheduling VRDs throughout the county as well as posting information concerning upcoming VRDs and volunteer slots available. 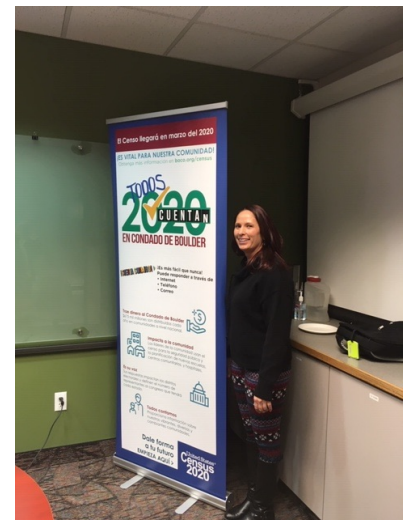
Launching the 2020 Census

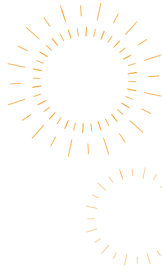
